

GENERAL CONDITIONS OF SALE

1. Acceptance of the conditions

The customer acknowledges to have acquainted, at the time of the signing of the order, special conditions of sale expressed on this screen and expressly declares to accept them without reserve. The current general conditions of sale govern the contractual relations between Geodd.com and its customers, both parties accept them without reserve.

These general conditions of sale are applied whatever the order means chosen: by Internet or quite other order placing means.

They can be changed at any time, the customer is thus invited to read them regularly. The orders are managed by the on-line general conditions at the date of the order.

2. Products

The Company does its utmost to present at the best products through photos or available specification sheets. The mother languages of the customers being numerous, it is possible that the using notes may not be available in a few languages or only available on the web site in download. The main products offered by Geodd.com to its customers are available in its warehouse. The classifications of products in the customs list are: 3926909790 for the pyramid and 3919901090 for the patch.

3. Order

The customer can place his order by Internet, by fax or by mail and fills himself his personal details. The company will not be responsible for the mistakes due to bad forwarding of emails, nor errors regarding the dispatching of the parcels due to a badly filled form.

Each customer can cancel his order at any time before it gets charged, by sending a fax, an email or a mail with all the important information (name, address, date and amount of the order).

In case of invoicing and dispatching of the order and if the customer does not really wish any more the products that he ordered, he has to refuse the parcel

on receiving it. We mean: he sends it back without opening it and write "refused parcel".

Our products offers and prices are valid as long as they are shown on the website, within the limits of available stocks. If necessary, more information can be given by telephone, email or fax. If Geodd.com is for a moment in stock shortage on a product for more than 8 days, it would notify the delay to the customer by return of email and this one could choose to wait, to change his order towards another choice in the range of Geodd.com products or to cancel his order.

Geodd.com reserves the right to cancel or to refuse a customer's order with whom there would be a dispute concerning a previous order.

4. Becoming Retailer

The customer can be interested to resell Geodd.com products. In that case, he has to fill in an identification sheet on the website, to communicate his recording number with regard to the Commercial Register of his country and let know his motivations. Geodd.com reserves the right to accept or not his application. If he is accepted as retailer, he will be granted a special discounted price-list, according to a compulsory minimum order amount and will also have the possibility to manage his account on-line. Otherwise, as regards the other points of the order: - Delivery – Payment..., conditions remain the same as customer's ones.

Geodd.com reserves the right to cancel or refuse an order from a retailer with whom there would be a dispute concerning a previous order.

5. Delivery times

The orders are carried out every day from Monday till Friday. Orders time limit changes according to the chosen means of payment, to the availability of stocks, to procedures in force in the company and in the country of receipt of the order.

Geodd.com undertakes to deliver to the post office all the references ordered by the buyer. The dispatching are done as follows: "expert F Colissimo", handed against signature (formerly: "followed colissimo"). The limit time delivery indicated by post is from 3 to 9 working days unless a specific delivery period is indicated on the detailed sheet. The Post department delivers the order to the address written by the customer.

Geodd.com cannot be considered as responsible for possible late delivery due to a routing delayed by post or quite any other intermediary. In case of delay, the customer has to contact first and foremost his distributing post office. Actually, in case of absence of the customer, the parcel must be taken at the post office with an identity card.

In case of turned out delay in delivery, the customer has to quickly contact Geodd.com to make open an inquiry for the location of the parcel: it may be misled and Geodd.com will take charge with making a file of complaint open. In this situation, it is thus possible that the company asks the customer necessary documents for the settlement of the file. The answer, linked by that of the transport company, can be two types: either the parcel is found and it goes on its routing up to the customer, or the parcel is declared lost and Geodd.com informs the customer about it. This last one will decide on the return of the goods or on a refund requirement (on the charged amount).

In receipt of the parcel by the customer, this one has a 48 hours period to indicate in writing (email, fax or registered mail) any complaint of nonconformity of products as regards: kind, quality or quantity with regard to the indications appearing on the invoice. Any complaint not done in rules, as defined above, can't be taken into account and will release Geodd.com from any responsibility towards the customer.

In case of strikes of the post office or one of its partners, Geodd.com will do its utmost to inform the customer about the delay, but the responsibility of Geodd.com can't be committed. In every case of act of God (climatic, armed conflict...), in France or abroad, Geodd.com reserves the right to interrupt the dealings with the concerned areas without committing its responsibility.

The customer has to inquire with the local authorities of his residence about the conditions of import and use of the ordered products and has to make any declaration or payment corresponding to the demand of the competent authorities in the country (D.D.U. Incoterm).

The customer has a 7 days legal period as from the receipt of articles for cancelling his order. In case of exchange or refund, he sends back the new article (s) in its (their) packaging (s) of origin, not damaged, with all the accessories, the using notes and documentations at the following address: Geodd.com-BP 362 - 22603 LOUDEAC (France).

In case of exercise of the cancellation right, Geodd .com will have to pay back the amounts paid by the customer, except the delivery expenses. The reimbursement is due for a maximum period of 15 days after receiving the returned goods. The expenses of return and packaging are chargeable to the customer. The customer has to inform Geodd.com about his requirement of return and previously let know our trade department in writing (email, fax, mail) and arranges then a 5 days period to return the parcel, in a quality packaging similar to that of the packaging of origin, to the address indicated above, as attested by date on postmark. He also has to join a copy of the invoice and of his complaint.

The customer really notes that this return of delivery is under its own responsibility and that in case of loss, it belongs to him to be able to make the necessary steps of location. Since the dealings already have taken place, the responsibility of Geodd.com can't be committed any more.

6. Price

The price is written and debited in Euro. The price, indicated on product sheets does not include the transport cost. The price indicated in the handling and confirmation of order is the final price and includes the price of products, the costs of handling, packaging, preservation of products and transport fees.

The price is written inclusive of all taxes by 19,6 % for sales concluded with residents from metropolitan France, Corsica, Monaco or European Union. The attached invoice with the goods gives evidence that the VAT was paid.

The VAT does not apply to the companies from the European Union which aren't French since they already have their own V.A.T. number, nor to companies settled in French Overseas Departments (DOM and TOM), as well as to all other cases.

Nevertheless, according to the current locally legislation, products are taxed (local VAT, sea granting, customs duties) upon arrival.

The mentioned taxes are chargeable to the customer who has to inquire with his administration.

A refusal of the goods for this reason can't be acceptable by Geodd.com.

7. Secured payment

The price charged to the customer is the indicated price on the confirmation of order sent to him by Geodd.com by email, if this e-mail address was passed on to us and valid.

Several means of payment are proposed but only the first one is accepted on internet:

- Credit card and paypal account
- Cheque
- cash

Credit card

We accept the following credit cards: Euro Card, Visa, Master Card as well as those accepted by Paypal.

The order will be carried out at once.

To assure safe and protected communication on your data, we use SSL coding technique (Secure Sockets Layer). The certification takes place via an authority of recognized certification, in this particular case: “Crédit Agricole” from “Côtes d’Armor” (France). This bank will intervene as regards payments made on the website, in metropolitan France and by the Paypal platform.

During the purchase, a debit request will be sent to your bank by means of our Terminal of Electronic Payment (TPE). The order will be really validated when the centres of banking payment will have given their agreement. In case of refusal of the said centre, the order will automatically be cancelled and the customer warned by e-mail.

Cheque

The customer has to send his cheque, drawn up in the name of Geodd.com with a copy of the order at the following address: Geodd.com-BP 362 - 22603 LOUDEAC (France).

The order will be handled from receipt of the cheque, but the customer will not be informed about it.

Cash

A cash payment has to be the subject of a preliminary acceptance by Geodd.com. The modalities will be confirmed in writing at this moment.

Whatever the means of order and payment, the customer receives his invoice during the delivery, in his parcel. Geodd.com keeps a digital copy of every invoice in indefinite duration and invoices are shown and downloadable on-line for the last 3 transactions as for the customers and over the last 12 months as regards the retailers, concerning the placed on-line orders.

8. Disputes

The present contract is subjected to the French law. In case of disputes which couldn't have been settled out of Court by mutual agreement, the court of the head office of Geodd.com will be the only Court of jurisdiction.

9. Warranty - liability

Devices sold under the patented and registered trade-mark Geodd.com are not liable to deterioration, their technology is reliable as far as we respect the way of using them and the different using fields shown and drawn on the packaging of products. The loss, the theft, the damage of the inside of the device by a bad handling or bad use can't commit the responsibility of Geodd.com.

Also, Geodd.com can't be considered as responsible for non compliance with the current regulatory and legislative measures in the country of receipt. The responsibility of Geodd.com limiting itself to the value of the said product, value at the date of sale and without possibility of appeal to the mark. In any hypothesis, the customer benefits of the legal guarantee of the hidden defects, provided that he gave evidence of it. The responsibility of Geodd.com will be limited to the amount of the order.

10. Legal information

The nominal and specific information collected for the purposes of the mail-order selling are compulsory, these information being necessary for the handling and the routing of the orders and the issuing of invoices. Missing of information entails the cancellation of the order.

According to the Computing law and Liberties of January 6th, 1978, the customer has a right of access, modification, rectification and deletion of his data, which he can exercise with Geodd.com.
